**( For supply as well as Installation & Commissioning of equipment**

**Technical specification & scope of supply:-**

**(1.0) Specification /Description of Machine body and various Machine parts :-**

*The MOC of all major items of the machine should be of SS and others are to be treated with Aluminium protected with weather proof paints.*
